


#### Our people






#### **Our culture**



# **Applying to McCann FitzGerald LLP**

Tips on getting here

A great academic record is important, but we are also interested in learning about who you are as a person.



#### The application form

- Take your time completing the application form, and read over it several times. Poor spelling or grammar is easy to overlook, but can make a bad first impression.
- Include as much information as possible. Our partners want to get a real sense of who you are and what interests you.
- Ask someone to look over your form before you press send. A fresh pair of eyes may spot something you've missed.
- Print a copy of your completed form and familiarise yourself with what you have written. Your answers may be discussed at the interview stage.




#### The online assessment

- The strengths-based assessment is designed to explore what motivates and energises you.
- The assessment will consist of scenario-based questions, questions about your working style, and critical reasoning questions.
- To achieve your best, find a place where you feel comfortable and at ease when completing the assessment.
- Be honest and authentic. When choosing your response, think about how you would behave in that scenario, and what your natural reaction would be.
- Read the scenario and response options carefully. Our behavioural assessment is not timed, so take your time to fully understand what the question is asking you.
- Don't overthink it or try to preempt what the firm might 'want' you to say. The purpose of these assessments is to understand your natural Strengths.
- Use the <u>Preparation Hub</u> created by our test provider Cappfinity, to do some practice questions so you know what to expect.
- You should complete the assessment in one sitting and we recommend allowing at least 60 minutes to complete it.

#### Preparing for the interview

- Do your homework and be prepared to show that you are informed about our industry, our firm and the role.
- Know your own skills and strengths and be ready to talk about them.
- Keep up to date with current affairs.
- Remember, we want to get to know you and find out why you want to work in commercial law and with McCann FitzGerald LLP in particular. We are genuinely interested in what you have to say, and we want you to succeed.
