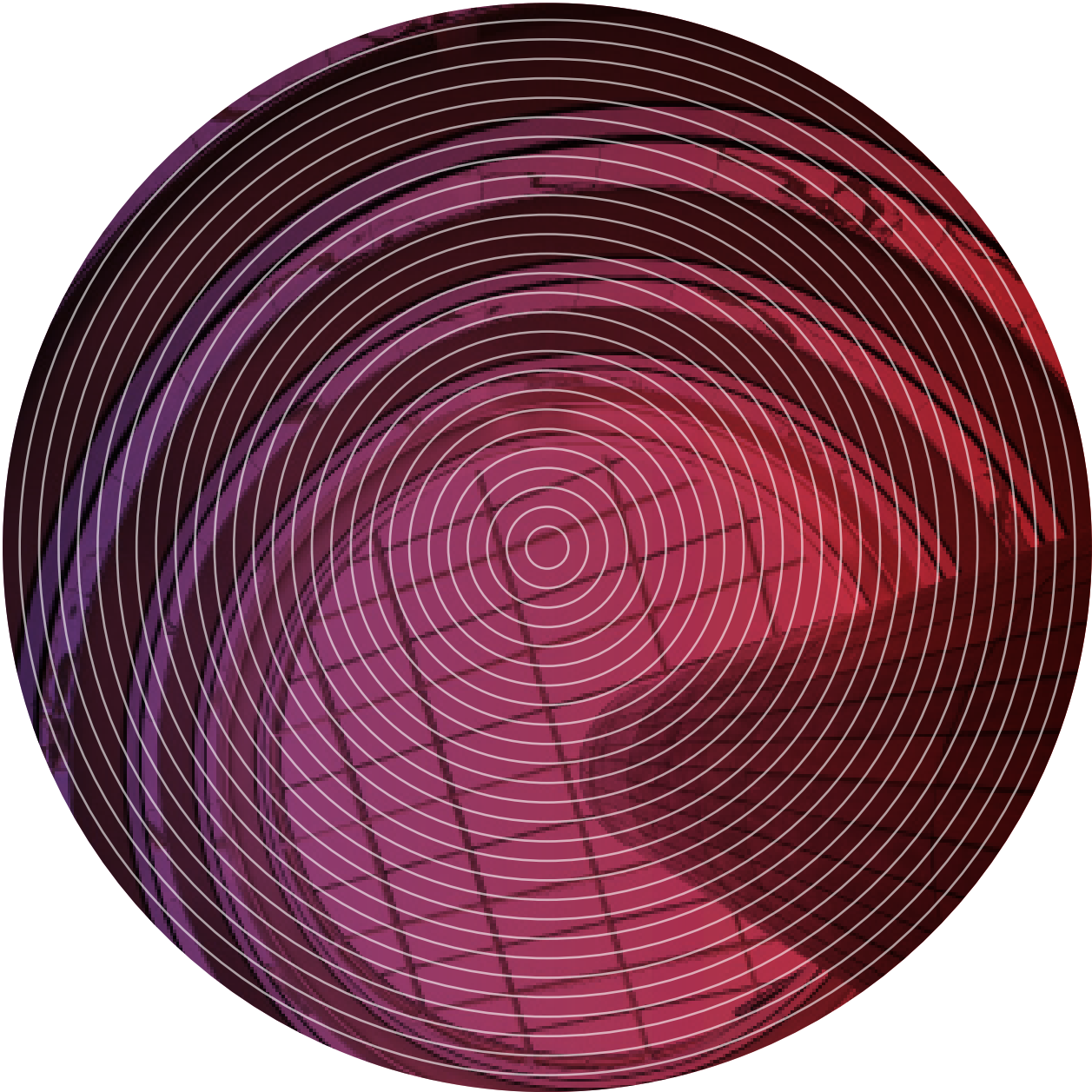

### New Entrants

### Projects

- Monitoring deadlines by which mandatory reporting must be completed, implementing reminders and preparing schedules of required information for completion
- Integrating with our company secretarial service for filings with the Companies Registration Office

### Knowledge and Training

- Providing monthly or other periodic updates with respect to specified areas of law and regulation
- Staff, executive and board training and CPD to meet minimum competency requirements

### Assurance Reviews

- Conducting risk reviews and providing advice
- Analysing existing compliance processes and frameworks and identifying where they can be improved, providing pragmatic solutions for remediation
- Assurance-testing and reporting with respect to controls and processes, including providing independent third party reports where required by the Central Bank

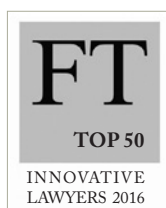
